Orders with no recipient name, payment or zip code will be severely delayed.

SHIPPING TIME

Customers must allow two to three weeks for shipping unless the rush option is indicated on this order form. Rush orders are shipped 2nd day delivery, but in order to go out the same business day, orders must be placed **online** by 1:00 p.m. Eastern. If **online** rush orders are placed later than 1:00 p.m. Eastern, they will be shipped the following business day via 2nd day delivery. **Faxed and mailed order forms have additional processing time.** Overnight shipping is available for a total of two times Air Rush 2nd Day total. International shipping is available. Delivery time will depend on country of destination and courier service.
