Examination Postponement Policy

If a candidate is unable to take an examination within the scheduled window, the exam may be postponed to a future window.

The candidate **must**:

1. Cancel the scheduled exam appointment with Prometric (a Prometric cancellation fee may be collected-see below). The RPA staff cannot assist with canceling an appointment with Prometric. **If a candidate fails to appear for a scheduled RPA examination appointment or cancels his/her appointment less than 2 days (48 hours) before the scheduled appointment, the entire registration fee will be forfeited and postponement will not be allowed.** A-4 exam is not administered at Prometric; candidate must notify Proctor and RPA if postponing exam.
2. Submit the Examination Postponement Form to the ASPPA office by the postponement deadline with the postponement fee of \$140. The postponement form and fee must be received by ASPPA on or before the postponement deadline. The postmark date is irrelevant.

A candidate who does not submit an Examination Postponement Form by the deadline date forfeits the examination registration fee. **There will be no exceptions.** If it is necessary to postpone an examination, note that the study materials purchased in preparation for the examination may not be the current study materials for examinations in a future calendar year.

Exam Appointment Rescheduling/Cancellation Policy

After registering and receiving an eligibility email (approximately 6-8 weeks prior to the exam window offering) a candidate can reschedule the date, time and location of a scheduled examination appointment within the same testing window – the candidate must contact Prometric by telephone (1-888-215-4136). Fees do apply and will be collected by Prometric at the time of rescheduling or cancelling an appointment.

In addition to paying the RPA postponement fee of \$140, the 2017 Prometric fees include (prices and timeframes subject to change):

- Reschedule appointment 30 or more days before exam appointment – no fee is charged.
- Reschedule or cancel appointment 2-29 days before exam appointment - \$35 fee.
- Reschedule or cancel appointment less than 2 days (48 hours) before exam appointment:
 - \$95 fee for CPFA, TGPC-2, DC-1, DC-2, DC-3 or DB
 - \$104 fee for CPC
 - \$123 fee for internationally administered DC-1 and DC-2 exams
